## INVITATION TO BID

---

The **Municipal Government of Sison**, Pangasinan through its Bids and Awards Committee (BAC), invites suppliers/ manufacturers/distributors/contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract/s:

Name of Project : Construction of Multi-Purpose Covered Court (Phase 1)  
Location : Dungon Integrated School, Dungon, Sison, Pangasinan  
Brief Description : Construction Project  
Approved Budget for the Contract : P3,299,986.59  
Source of Fund : Trust Fund and Special Education Fund  
Contract Duration : 125 days

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed, within five (5) years from the date of submission and receipt of bids, a contract similar with a value of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through an open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act". Prospective bidders should be registered with the PhilGEPS at [www.philgeps.net](http://www.philgeps.net).

Bidding is restricted to Filipino citizenship/sole proprietorships, partnership, or organization with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
